If hard copy is allowed then a complete then a complete set of Bidding Documents may be purchased from the office Solududhkunda Municipality, Salleri Solukhumbu and the by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs.1000.0 till 09-09-2022 05:00 during office hours.
4. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP i.e www.bopatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following account

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 11-09-2022 12:00 at the office of Solududhkunda municipality office salleri, Solukhumbu.

Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 90000, which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. [2020100303000005] at [Rastriya Banijya Bank Ltd. , salleri ,solukhumbu] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
