- Solududhkunda Municipality invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of Tapping, Lumsa, Juke, Damil Road upgrading work under National Competitive Bidding procedures. The estimated amount for the works is Rs 1,69,16,334.93 (one crore sixty nine lakh sixteen thousands three hundreds thirty four rupees ninety three paise) **including VAT and PS item.**

Bidders, submitting their bid electronically, should deposit the cost 3,000 (three thousands only) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - Sealed or electronic bids must be submitted to the office through PPMO website www.bolpatra.gov.np/egpon or before 2080/02/30 on 12:00 P.M. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 2080/02/30 2:00 P.M. at the office of Solududhkunda Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of 3,75,000 which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
